**Historical sketch:** These journals were printed by the State beginning in 1715 and often sent to or obtained by the Town Clerk or Town Selectmen in order to stay current with State issues.

**Scope and content**: This Collection was found in the attic of the old Town House on Green Street. The journals were read in order to discover information directly relevant to Kingston. Items of general interest in State and National history were also noted. These notes are included in the finding aid under each journal listing. They are to be used as examples of what each issue contains and are by no means meant to be a complete reflection of the content within each journal.
